10am Plenary: relationships

After being welcomed to City Hall and to the day, our opening plenary session will be looking at **relationships**. Whether we're talking about systems change and the interplay between issues, about communities and the organisations working with them, about the diversity of London's civil society, about participatory grantmaking, about trust, about how we work together as a funding community, relationships are at the heart of everything we do - but how should we be thinking about relationships in our work?

Building on the theme of relationships, we know that many issues that we discuss as funders are complex, and that sometimes looking at them in isolation doesn't enable us to build the thriving communities that we all wish to see - so we're bringing together our network groups to look at issues together, to learn from each other, and to think about how we can more effectively collaborate across issues, communities and funding priorities.

Research & Evaluation and Violence Affecting Young People - Living Room

Housing & Homelessness and Culture - CR5

Go to the lower ground floor to Committee Room 5 for this session, which will be exploring the role of housing providers in commissioning holistic cultural activities for the communities that they serve. The network chairs will be joined by Adriana Marques (Peabody) and Blossom Young (Poplar HARCA) for this discussion.

Civil society groups across the capital are busy developing manifesto asks of the next Mayor of London ahead of the election on 7th May, but many of the issues that are being discussed are things that need funders from across different sectors to be involved. We're keen that the excellent work of these groups, bringing together the voices of diverse communities across London, is used to inform the work of the wider funding community for the coming years.

Each of our tables will have a civil society group who will kick off discussions by presenting some of the ideas they are putting forward as part of their work on a Mayoral manifesto, to help inform a discussion on each table about how funders could work together on this issue to improve life for Londoners.

biographies

Allan Anderson

Allan Anderson is Senior Grant Making Manager for London at The National Community Lottery Fund, overseeing the Fund's grant giving and relationships across the capital. Allan previously worked in the voluntary sector for 16 years in health, latterly as CEO of Positively UK, a national HIV support organisation providing peer support and integrating community care within the NHS.



Catherine Anderson

Catherine Anderson is the CEO of The Jo Cox Foundation, prior to which she spent eight years as Chief of Staff to Rory Stewart. She has founded NGOs in India and in Myanmar. A Founding Director of 50:50 Parliament and an active campaigner at Women2Win, Catherine is committed to gender equality and empowering all women and girls to achieve their potential. In 2019 she was named as one of the Evening Standard's #Progress1000 most influential political changemakers.



Jeanette Bain-Burnett

Jeanette Bain-Burnett is Assistant Director for Communities and Social Policy at the Greater London Authority. Formerly Head of Community Engagement, she has supported the Mayor's office in engaging with London's diverse communities.

Jeanette's background is as a senior leader and consultant focusing on culture, community engagement and equality and diversity. She has worked for a range of organisations including the Association of Dance of the African Diaspora (ADAD), Arts Council England, the BBC, Middlesex University and the University of East London.



Matthew Brown

Matthew Brown started his career in HM Revenue and Customs and became an equal opportunities officer for the Public and Commercial Services Union. In 1997 he canvassed for Labour at the general election and was later persuaded to run for a council seat in what was then his home seat of Tulketh, north-west Preston. He won on his first attempt in 2002, aged 30.



He was appointed cabinet member for community engagement and inclusion almost nine years ago, in a city riven by inequality.

In the UK the 'Preston Model' has received substantial coverage as one of the first adopters of Community Wealth Building with over 50 areas in the UK also looking to implement this approach including the Scottish and Welsh Governments, Liverpool and Greater Manchester City Regions and a growing number of local authorities including many now in London.

The VCFS sector has a key role to play in supporting this agenda to ensure inequality is tackled and campaigning for a £4bn Community Wealth Fund nationally.

Cait Cooper

Cait Cooper is the Deputy Director for Mental Health and Wellbeing in Schools at the Anna Freud National Centre for Children and Families. Cait recently joined the Anna Freud Centre; in her previous post she was a member of a Senior Leadership team specialising in Inclusion and Safeguarding.



Cait has vast teaching experience and a strong understanding of the current education landscape; she is passionate about providing schools with the knowledge and tools necessary to support children and young people's mental health and wellbeing. At the Anna Freud Centre Cait takes strategic oversight of a large number of projects including training packages, government initiatives and the growing Schools in Mind network.



Jack Hopkins

Lambeth Labour Group elected Councillor Jack Hopkins to be the new leader of Lambeth Labour in January 2019 and the leader of Lambeth council. The election followed the announcement that Councillor Lib Peck, Leader of Lambeth council since 2012, was taking up a new role leading London's Violence Reduction Unit.





Adriana Marques

Adriana is an experienced curator and leader in the arts, with specialist knowledge of culture led regeneration. At Peabody she is developing an ambitious and long term cultural plan for Thamesmead as London's new town. This includes London's first Cultural Infrastructure Plan for Thamesmead; new creative workspaces, such as the Lakeside Centre run by Bow Arts; community-led and international festivals; a community radio station and archive, and the recent award of Creative People and Places funding from Arts Council England.



Previously, Adriana spent seven years embedding culture into London's Queen Elizabeth Olympic Park, before and after the London 2012 Games, and has written books on best practice public art.

Chris Martin

Chris Martin is CEO of The Mix which is a multi-issue advice and crisis support service for young people under 25 that works exclusively through digital and social channels and has a particular focus on supporting mental health. The Mix was one of the eight charity partners that delivered the ground breaking Heads Together campaign with the Duke & Duchess of Cambridge and Prince Harry. Chris is the CEO of The Mix, a fellow of the RSA, a gadget lover and a trustee of both Brook Young People and his local youth club, Harrow Club W10.



David Robinson

David Robinson is a community worker and writer in east London. He currently leads the Relationships Project, seeking to build a better society by building better relationships. Working with others, the Project is assembling a body of knowledge on relationship centred practice and design, and developing methods and models for applying that learning, place by place.



He is a co-founder of several organisations including Community Links, Discover and Shift, where is now co-chair, and is a founding director at Social Finance where he also chairs the Impact Incubator. He has previously led the Prime Ministers Council on Social Action, the National Early Action Task Force and the original London Advisory Board for what is now the National Lottery Community Fund. His books include Changing London (with Will Horwitz), Britain's Every Day Heroes (with Gordon Brown) and the million selling Change the World series (with We Are What We Do).

David's policy work has been recognised with an honorary doctorate from the Open University. He was also Practitioner in Residence at the LSE's Marshall Institute and has been described by the Guardian as "the godfather of the community sector, equally admired on the left and right".

Terry Stokes is Chief Executive of Lasa, the organisation delivering rightsnet, advicelocal and an array of webtools to support thousands of third sector and government bodies across the UK each year by providing knowledge, support and resources. Lasa is a small but impactful organisation, with a singular and important value proposition in the social welfare law landscape - to use technology to support the delivery of high quality advice. Lasa occupies an important position within this sector through its online forums facilitating discussions from front line advisers across the country.



Terry has over thirty years of advice giving experience in the third and public sectors and is a keen advocate of the value the advice sector provides in supporting communities and ensuring good advice for all.

Ben Thurman

Ben joined the Carnegie UK Trust in June 2018, with a background in policy and research in the voluntary sector in Scotland and abroad.

Over the last 18 months, Ben has led and developed the Trust's work on kindness, including coordinating practitioner networks, working in partnership with local government, and supporting a variety of organisational and place-based kindness initiatives across the UK.



Blossom Young

With Poplar HARCA's Accents team, Blossom leads social, economic and cultural regeneration strategies in East London. Accents conceives and delivers projects that grow cohesive places, whilst creating sustainable revenues that bring investment into the community.



Blossom recently led Poplar Works, a £6m multi-faceted fashion hub, developed the award-winning Open Poplar programme and is currently developing a new economic strategy in the Lower Lea.
